1. GENERAL CONDITIONS

The Traveler will live with the Host for a period of time of days/weeks/months (*delete whichever doesn't apply*), starting on and ending on....., under the conditions specified in this private agreement. During this period, the Traveler will be given the opportunity to explore the host country and experience its culture through the safety of the Host's home, and the Host will gain exposure to the Traveler's culture while getting a pair of helping hands.

2. HOST DUTIES

2.1. The Host is committed to welcome the Traveler into their home and invite him/her to participate into the daily family life.

2.2. The Traveler's hours of duty shall be organized in such a way as to allow him/her to improve his/her general cultural development and knowledge of the language.

2.3. The Traveler shall have free day/s per week and shall have full opportunity to take part in religious worship. At least once a month, the time off shall fall on a weekend. In the cases where full-time help is provided, the traveler is also entitled to have 2 days off for every full month worked.

2.4. In the event of the Traveler's falling ill or having an accident, the Host shall continue to provide board and lodging and shall give all appropriate care until the necessary arrangements have been made.

2.5. Lodging. Host will provide the Traveler with (*check what applies*):

- A comfy couch or folding bed in a common area of the house (*recommended only for very short time*)
- A bed in a shared bedroom. Bedroom will be shared with
(please note that Traveler shall share bedroom only with same-gender family members)
- A bed in a private bedroom
- Other (*please specify*)

2.6. Boarding. Host will provide the Traveler with (*check what applies*):

- Full board (breakfast, lunch and dinner)
- Half board (breakfast and one meal a day)
- Breakfast

2.7. Stipend (a stipend shall be paid when Traveler works for 5 hours per day or more, if visa restrictions and local regulations allow):

Host will NOT pay any money to Traveler (they will provide room and board in exchange for part-time help)

Host will pay the Traveler pocket money amounting to weekly (please always check local regulations to find out about the minimum wage in the host country).

3. TRAVELER DUTIES

3.1. The Traveler undertakes to help the Host for the following number of hours per day, in a maximum of days a week (*delete whichever doesn't apply*):
